Nahanni River Self-Guided Trip Planner and Registration Pamphlet 2009

We are pleased to provide you with a one stop outfitting service from both Fort Simpson and Lindberg Landing on the Liard River. The majority of river travelers complete their Nahanni trip at Blackstone Territorial Park. This is conveniently located within a few kilometers of our base at Lindberg Landing. Each season an increasing number of Nahanni paddlers are discovering the benefit of our fly out paddle back location. You can park your vehicle at our base or make use of the shuttle to Fort Nelson or Fort Simpson. The proximity of our base to the Nahanni River means shorter and less expensive multiple charter flights. We recommend that you compare commercial flights into Fort Nelson (www.flycma.com) with those of Fort Simpson (www.firstair.ca) when you are making your plans. In the October/08 the online available prices were \$600 compared to \$1500 CDN. In these times when we are looking for ways to reduce our carbon emissions you will be pleased to know that your output via Fort Nelson and our Lindberg Landing base is half that of the alternative via Fort Simpson. Greetings from Nahanni Wilderness Adventures!

The South Nahanni River is Canada's most celebrated wilderness river, featured in more films and books than perhaps any other river. Remotely located in the mountains east of the Yukon/NWT border, the Nahanni is accessible only by air. Fewer than 700 people per year run the Nahanni and approximately half of these organize their own adventure. Nahanni Wilderness Adventures has been pleased to serve the majority of these folks each year with our comprehensive, self-guided, one-stop supply of river outfitting equipment and logistical services from Lindberg Landing and Fort Simpson, NWT. Registration with Nahanni National Park Reserve:

Accommodation:

Lindberg Landing

Lindberg's Bed and Breakfast is a paddle-in B&B on the Liard River 40 km from Nahanni Butte and the junction between the Nahanni and the Liard Rivers. This is a great way to ease back into civilization and is highly preferred to camping next door at Blackstone Territorial Park. Price includes supper and breakfast, hot showers, rustic log cabin accommodations and the wonderful hospitality of Sue and Ed Lindberg. Rate: \$120/person per night. Only post- trip bookings are available.

Fort Simpson

Bannockland Inn is operated by Laurie and Brent Fichter. Far from rustic, this four-star B&B overlooks the confluence of the Mackenzie and the Liard Rivers just outside of Fort Simpson. Bannockland is the first choice for folks arriving early or staying over a night before leaving the area. The service includes luxurious, comfortable rooms with full baths. One room even boasts a Jacuzzi hot tub. A hot breakfast, satellite TV and free pickup and drop-off at the airport are also included. River Taxi Operations

The river taxi service is based in the Native village of Nahanni Butte. A contract operator provides service between the park boundary and Blackstone Territorial Park /Lindberg Landing.

Passengers, canoes, raft and equipment are transported inside large aluminum boats powered by outboard motors. River taxis can take 4 passengers/2 canoes and gear or 5 participants /1 raft and gear. The water taxi will meet you at an assigned time and location. Rates and payloads may vary based upon available water craft, weather and water conditions.

Road Shuttle from Fort Nelson to Blackstone Landing:

A 12-passenger van is available for pickup and return to the Fort Nelson airport from Lindberg's B&B and Blackstone Territorial Park. The rate is \$195/person each way with a minimum group rate of \$1000/trip). The time and location must be set in advance of your departure on the Nahanni.

Road Shuttle from Lindberg Landing to Fort Simpson:

Parking: If you drive to Lindberg Landing, parking can be arranged for \$1/day by speaking with Edwin or Sue Lindberg upon arrival. You will be asked to leave your keys at their house while you are away on your trip. Vehicles are left at your own risk.

General Information on Low Impact Camping:

Fires

Please note that fire boxes are now required for open fires in NNP-R.

A fire box is a collapsible metal box with a grate on top that all fits into a compact carrying case. A fire in this little invention is superior for cooking and requires a fraction of the wood. In environmental terms, a fire box used on sand or stones prevents a fire scar from being formed. The draft created by the box will burn your wood to a fine ash that can then be diluted in the river. Use driftwood and deadwood from the forest floor. Refrain from leaving signs of axe or saw use on wood not used and left behind.

Latrines

Where possible, dig latrines 50 m away from the river and other water sources. Try to dig into organic soil. The hole should be at least six inches deep. When finished, instruct participants to mix soil with faeces for quicker decomposition and cover with at least two inches of soil. Camouflage the surface. All toilet paper, sanitary napkins, tampons must be packed out or burned completely.

Bathing

Bathe in river using biodegradable soap. Portable showers may also be used in the trees, also using biodegradable soap.

Garbage

Food - Burn all food scraps completely even if it means bagging the scraps and burning them in the supper fire.

Paper - burn completely

Plastic and foams - Wash to remove food odors and pack out.

Cans – Burn or wash well to remove smell, then flatten and pack out.

Toilet Paper and Sanitary Napkins - Burn in a very hot fire or pack out.

Fish entrails - Burn completely in a very hot fire.

Waste water from dishes or cooking

After straining through a fine mesh screen, scatter any such water into the fast moving flow of the river. Dilution of grey water is acceptable on large, fast flowing rivers.

Campsite Selection

Tents should be pitched in areas with little vegetation. The best location for minimum impact is on the floodplain of the river. Leave the campsite as clean as possible and never dig trenches, cut trees or move rocks to make the site more pleasant. If rocks are needed for securing tents, pick loose ones from below the high water line.

Wildlife

Respect the needs of all wildlife. The simplest way to avoid disturbing wildlife is to avoid practices that may attract them, causing them to become dependent on human food and lose their wildness and possibly their lives. Harassment occurs when an animal is encountered while hiking, if the group camps close to a nest or approaching closely to take a photograph. The animal's reaction is excitement, alarm and flight, all of which consume energy needed for growth and reproduction. Learn about the animals in the area; their habits, habitat, nest sites, etc. Armed with this knowledge, make informed decisions about where to travel and camp to avoid undue harassment. Remember the Nahanni and area is one of the last bastions for truly wild species; if we drive them from here, there will be nowhere left for them to go.

Note: In frequently visited areas such as RKL and VF, grey jays, ravens and red squirrels have become scavengers. Keep food sealed in hard, plastic containers to protect it and the animals from continuing the habit. Both these areas are among the lushest in the Park and have abundant natural food.

CONDITIONS OF RENTAL CONTRACT

1. **BOOKING DEPOSIT:** A 25% (non-refundable) deposit of the total fee is required to confirm the afore-mentioned equipment rental. Final payment (also non-refundable) is required 60 days prior to picking up of equipment. Please note that all reservations for flights, ground transport and accommodation are binding. Alternate arrangements made at the time of the trip are done so at the expense of the client without the option of a refund.

2. **INSURANCE:** Nahanni Wilderness Adventures Ltd. does not have insurance coverage on these items and you are assuming full responsibility for this gear while it is in your possession. We recommend that you extend your personal home insurance to cover these items while they are your responsibility.

3. **RETURNS:** All equipment must be returned to our base at Lindberg Landing. Late returns will be billed at 2 X (twice) the daily rental fee unless pre-arranged. Early returns are not eligible for a refund.

4. **DAMAGED/LOST GEAR:** You are responsible for the full costs of NWA repairing damaged or replacing lost/stolen equipment. Please take good care of this equipment and treat it as if it were your own. We do expect to see normal wear on equipment, so please let us know if something is not functioning properly.

5. **DAMAGE DEPOSIT:** A credit card number (VISA or M/C) will be held as a damage deposit. Please be aware that the cost of any damage or losses will be charged to this card. The replacement cost of a canoe and gear is \$2200. The replacement cost of a raft is \$6500. A NWA representative will inspect your equipment upon its return.

6. **CHECK OUT/IN:** An NWA representative may not be available when you pick up or return your equipment to our base. Your flight charter company will help you transport your boats and other gear to the float dock.

7. **COMPLETED FORM:** All persons engaging in the use of the said equipment must complete the NWA Notice and Release form and return these with the final payment.

8. **SCHEDULES:** While you may have booked your self- guided services months in advance there are situations that are outside of our control which may effect the timing of the services you have arranged. Your flight charter arrangements are the most susceptible to delays. Weather, mechanical problems and pilot hourly limits can all lead to flight delays. We ask you to appreciate these limitations when you arrive in the North and understand that we will be doing everything we can to keep you on schedule.

9. **EQUIPMENT CLEANING:** Our rental rates do not include cleaning by our staff. Equipment must be returned to the NWA base at Lindberg Landing in the same clean condition it was received. Please allow yourself time to take care of this task when organizing your departure schedule. A cleaning charge equal to the single day rental fee will be applied to any item that in NWA's view must be cleaned before being issued to another rental group. Cleaning supplies and water is supplied at our base.

1. WAIVER AND RELEASE:

In consideration of my being permitted to participate at my request in the operations offered or organized by NAHANNI WILDERNESS ADVENTURES LTD. ("NWA"), (the "Trip"), I, on behalf of myself, my heirs, executors, successors, administrators and assigns, hereby waive any and all claims I or such parties may have now or in the future and release from all liability and forever discharge NWA and its directors, officers, agents, servants, employees and representatives, including independent contractors and its or their successors, heirs and assigns (collectively, the "Releasees") of and from all actions, causes of action and claims of every nature or kind whatsoever, including but not limited to those associated with any damage, loss, DEATH, or injury to myself or my property (the "Lawsuit"), howsoever caused, arising out of, or in any way connected with, my or my minor child's participation in the Trip and notwithstanding that the same may have been contributed to or occasioned by the negligence of the Releasees or any of them.

2. ASSUMPTION OF RISK:

I am aware of the dangers and risks inherent in the Trip and in travel in remote areas, including, but not restricted to: travel over bodies of water involving rapids, hypothermia, drowning, inclement weather, flash floods, forest fires, confrontation with wildlife including bears, slipping and falling, falling objects, travel in motor vehicles, motorized watercraft, helicopter and light fixed-wing aircraft, and/or suffering any type of accident or illness in remote areas without access to medical facilities. I freely and voluntarily acknowledge and assume all of these risks and any unforeseeable risks associated with the Trip and the possibility of personal injury, DEATH, property damage, or loss resulting therefrom and acknowledge that the Releasees do not assume any responsibility whatsoever for my safety during the Trip.

3. INDEMNITY:

If for any reason a Lawsuit is started by myself, my family or my heirs against the Releasees, I agree to pay as liquidated damages for any suit all costs, including legal fees costs on a solicitor and his own client basis incurred by the Releasees or its representative in defending such an action.

4. I agree to learn and abide by safety rules and procedures established by the NWA and to make NWA aware at any point in which I question my knowledge of these procedures or my ability to participate in the Trip.

5. I confirm that I am physically able and fit to participate in the Trip and do not have any medical condition or needs that have not been listed on the personal data form supplied by NWA. I consent to receive first aid rendered to me by NWA and agree to pay the costs of any rescue or medical attention rendered to me, my belongings or for my benefit.

6. I agree that I will not be under the influence of any alcohol or drugs which may impair my participation in the Trip.

7. I agree that NWA and other members of the Trip are permitted to take film and photographic records of my participation in the Trip and use same for personal or promotional use.

8. I agree that I am responsible for my own insurance coverage.

9. I agree that in response to unexpected changes in weather, water level or any other conditions, the Operator may alter or change the itinerary of the Trip at any time and without penalty or refund liabilities.

11. I agree that all Lawsuits concerning any part of this agreement will be held in Canmore, Alberta, Canada and that the laws of Canada will be the laws governing any said Lawsuits.

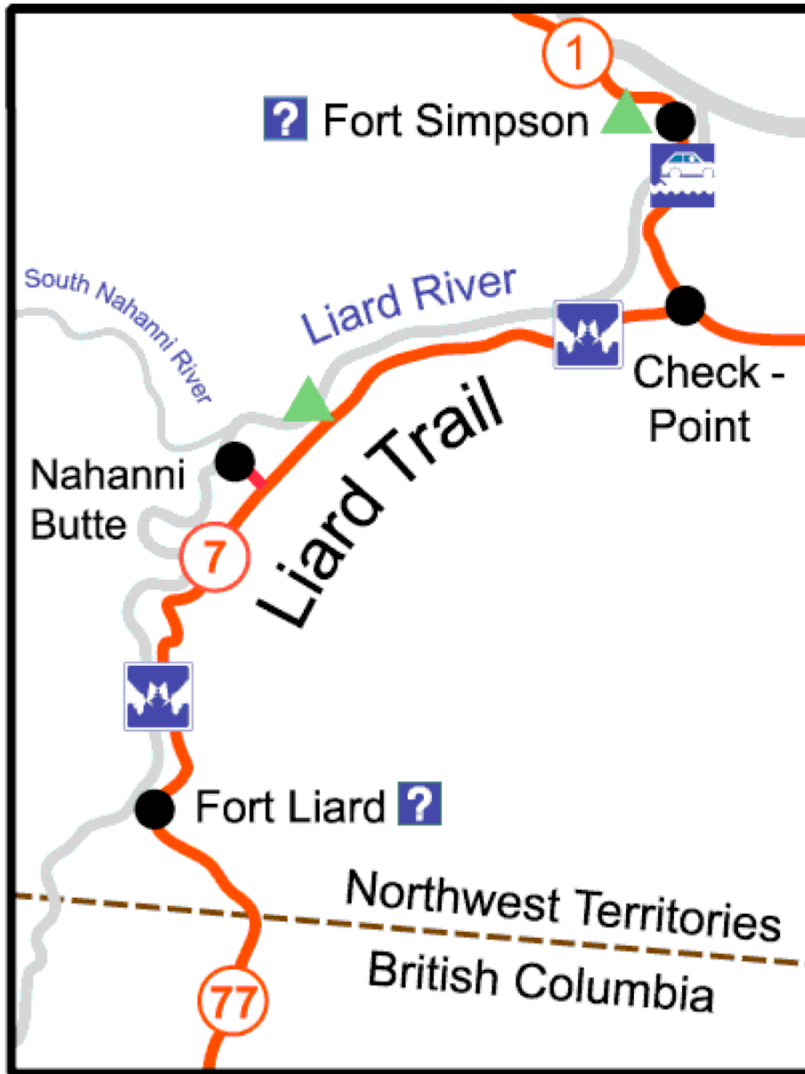
